PROPOSED CONSTRUCTION AND REHABILITATION OF VARIOUS  
WORKS**

1. This Invitation for Tenders follows the General Procurement Notice for these Projects which appeared in Mtanzania and The African news papers of 20<sup>th</sup> October, 2010 respectively.
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the Regional Administrative Secretary Kagera during the financial year 2010/2011. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contracts for the:
  - BID No RAS/019/2010/11/W/04 PROPOSED CONSTRUCTION OF MISSENYI DISTRICT ADMINISTRATIVE SECRETARY'S HOUSE [PHASE II] AT BUNAZI TOWNSHIP.
  - BID No RAS/019/2010/11/W/08 PROPOSED CONSTRUCTION OF SECURITY FENCE AT BUKOBA REST HOUSE.
  - BID No RAS/019/2010/11/W/09 REHABILITATION OF MULEBA REST HOUSE.

The Regional Administrative Secretary KAGERA now invites sealed tenders from eligible contractors registered in **class SIX and above for bids No RAS/019/2010/11/W/04 and No RAS/019/2010/11/W/08** and being registered in **class SEVEN and above for bid No RAS/019/2010/11/W/09** for carrying out the above listed works. 4. Bidding will be conducted through National competitive bidding procedures; specified in the Public Procurement (Goods, Works, Non Consultant Services and Disposal of Public Assets by Tender) Regulations, 2005 - Government Notice No. 97 and is open to all bidders as defined in the Regulation.

5. Interested eligible bidders may obtain further information from and inspect the Tendering Documents at the office of the the **Secretary, Kagera Regional Tender Board, P. O. Box 299, Bukoba. Room No 9, located at Ground floor of Kagera Regional Block Building** from 08.00hrs to 15.30 hrs on Monday to Friday inclusive except on public holidays
6. A complete set of Bidding Document(s) in English language and additional sets may be purchased by interested Bidders on the submission of a written application to the address given under **paragraph 5 above** and upon payment of a non-refundable fee of Tshs. 100,000 (**One hundred thousand only**) in local currency payable by cash, or bank draft or banker's cheque to the **Regional Administrative Secretary, Kagera.**
7. All Tenders must be accompanied by a Tender securing declaration in the format provided in the tendering documents.

All tenders in one original plus TWO COPIES properly filled in, and enclosed in plain Sealed Envelopes either delivered by hand to **Room No. 40 located to 1<sup>st</sup> floor at Kagera Regional Block** or by **Registered mail to the Secretary Regional Tender Board P.O. Box 299 Bukoba** so as to reach on or before **14.00 hours Tuesday 5<sup>th</sup> April, 2011** and clearly marked **BID NUMBER AND DESCRIPTION OF WORKS**. 9. Deadline for submission will be on 5<sup>th</sup> April, 2011 at 14.00 hrs. Bids will be opened promptly thereafter in public and in the presence of those Bidders or their representatives who will choose to attend in the Regional Administrative Secretary's conference Room located at 1<sup>st</sup> floor of Kagera Regional Block.
10. Late bids, portion of bids, electronic bids, and bids not received, bids not opened at opening ceremony shall not be considered for evaluation irrespective of the circumstances.
